**TO SERVE AS AN ELECTION JUDGE:**

**You must be:**

(M.S. 204B.19, Subd. 2; 204B.21; 204B.25)

- 1. Eligible to vote in the State of Minnesota; and
- 2. Able to read, write and speak English; and
- 3. Appointed by the appointing authority (county, city, township, or school board); and
- 4. Trained and currently certified as an election judge. Two hours of training is required to serve as an election judge in Minnesota. Training dates will be announced at a later date.

**An election judge cannot be:**

(M.S. 204B.19, Subd. 1 & 2.)

- 1. A candidate in that election (i.e., they are running for an office on the ballot used in that precinct); or
- 2. The husband, wife, parent, child, brother, or sister of a candidate or another judge in the same precinct; or
- 3. A challenger.

**PLEASE READ THE FOLLOWING CAREFULLY AND SIGN THIS APPLICATION IF YOU AGREE:**

To ensure fair and honest elections results, if selected to serve as an election judge, I will adhere to the following:

- I will arrive at my assigned polling place, at the assigned time, and remain until my assigned time is completed or excused by the Head Judge
- I agree to be courteous, respectful and to assist all voters regardless of national origin, physical challenge, or efficiency in the English language.
- I agree to read and study the Election Judge Guide and any additional information. I will attend the election judge training so that I am prepared to fulfill my assigned responsibilities to conduct the election according to federal, state and local elections, laws and policies.
- I understand that we are responsible for the security of the election equipment and supplies and I will handle and monitor all such equipment and supplies exactly as instructed.
- I agree to report immediately to the head judge any malfunction or possible tampering of voting equipment, unusual or suspicious behavior occurring in the polling place or any other event or occurrence that may threaten accurate gathering or sanctity of the vote.
- I will refrain from making personal or political opinion comments while serving as an election judge.
- I certify that all information I have provided on the application is correct and that I have not omitted any information. I understand that giving false information or omitting requested data may disqualify me from further consideration as an election judge or result in dismissal, if discovered at a later date.
- I authorized the City of Chaska to verify the information I have provided.
